#### What is the background of this policy?

Nestle products are used within Heriot Watt University Student Union.

There has been a boycott of Nestle since the 1970s. This began in the United States and expanded to Europe. It was prompted by concern about Nestlé's "aggressive marketing" of <a href="mailto:breast\_milk">breast\_milk</a> substitutes, particularly in <a href="mailto:less economically developed countries">less economically developed countries</a>, which campaigners claim contributes to the unnecessary suffering and deaths of babies, largely among the poor.

The boycott continues today and as of 2013 is coordinated by the International Nestlé Boycott Committee (INBC).

Some universities, colleges, and schools have banned the sale of Nestlé products from their shops and vending machines in the period since the revelations. In the United Kingdom, 73 student unions, 102 businesses, 30 faith groups, 20 health groups, 33 consumer groups, 18 local authorities, 12 Trade Unions, education groups, 31 MPs, and many celebrities support the Nestlé boycott.
